However, Central and State governments in India proposed to introduce "**Goods and Service Tax (GST)**" from 1st July a comprehensive tax **levy on manufacture, sale and consumption of goods and service** at a national level under which no distinction is made between goods and services for levying of tax. It will mostly **substitute almost all indirect taxes** levied on goods and services.

Client had to implement GST in SAP R/3 to comply this requirement.

Business requirement is GST Implementation across its two locations under two GST Registrations configured in SAP.
